Secondary Windows Guarantee - Products, Materials and Workmanship

1. Subject to the conditions set out below the Company guarantees that the products supplied will be free from inherent defects in materials and workmanship for a period of:
 - A. **Aluminium** Frames and Sashes - 10 years
 - B. **Glass** - 10 years
 - C. all **Fixed Parts** including but not limited to screw fixings and corner cleat fixings - 10 years
 - D. all **Moving Parts** including but not limited to locks, handles, hinges, rollers and spiral balances - 5 years
2. **Secondary Glazing Glass:**
 - A. All Glass will be manufactured and supplied in strict accordance with BS 6262, BS 6206 and Section N1 of Approved Document N of the Building Regulations - which between them specify the Safety Glazing requirements for all areas of "Special Risk," including "Bathing and Washing Areas."
 - B. where the Company has both surveyed for and installed the products it shall be responsible for 2 (A) above.
 - C. in any other circumstance including but not limited to secondary glazing DIY and Trade Supplies the Customer shall be responsible for 2 (A) above.

Secondary Glazing Guarantee - Installation

3. The Company guarantees that all **Secondary Glazing Installations** carried out by the Company will be free from inherent defects in Workmanship and Installation Materials for a period of 10 years.

The Customer(s) Responsibilities

4. It is an **Implicit Term of this Guarantee** that **Customer(s)** will ensure that all products are used and maintained in accordance with the Company's Operating and Maintenance Instructions, which can be downloaded [here](#).

5. If the property where the products have been installed changes ownership then the remaining term of the guarantee is **Transferable without Charge**.
